AWARDS CRITERIA & NOMINATING INFORMATION

NOMINATIONS

Who is eligible to nominate? Anyone can nominate. Yes, ANYONE!

Can I nominate multiple people? Yes. In fact, the more brilliant women you nominate, the better.

Can I nominate someone again who wasn't selected in 2024/25? Absolutely! A previous nomination has no impact on this year's outcome. In fact, if your nominee has made a significant impact over the past 12 months, we strongly encourage you to put her forward again.

Can I nominate myself? Yes. There will be a higher weighting for those who are nominated by others. Why? Because the Awards are, in part, about identifying those who would not ordinarily put themselves forward for recognition.

WHO ARE THE AWARDS FOR?

Who can be nominated? Action-orientated women who are leading the climate revolution across the 10 different Award categories (think finance, investment, policy, industry, law, innovation and operators); those who see simultaneously the incredible opportunities whilst understanding the deep urgency of the climate crises. We are looking for women who work tirelessly to identify, solve, and unlock business climate solutions.

WHAT ATTRIBUTES ARE WE LOOKING FOR IN OUR NOMINEES?

Delivery - those who have a demonstrable track record of positively changing the status quo by unlocking tangible solutions that inch us closer to solving the wide variety of climate issues.

Generosity - those supporting and collaborating with others to create meaningful breakthroughs and unlocks.

Commitment - those getting the work done whatever the obstacles.

Selflessness - those raising other women.

Above and Beyond - while we know that in reality it is never just about one person, the Awards are an opportunity to acknowledge those who have, and are, going above and beyond to unlock real climate solutions.

AWARDS CRITERIA & NOMINATING INFORMATION

JUDGING

How will the judging work? Our judging panel will, once again, bring together a diverse group of carefully selected advisors, partners, and climate leaders. In addition, winners from Year 1 will be invited to join the judging committee, helping to shape the process as the awards develop year after year.

How many categories are there? Ten categories (see Fin-Erth website for the definitive category breakdown).

What will the final list look like? The final list of the 101 Women in Climate will be highly curated and include 10 names for each Award category and an extra name for someone who defies categorisation and whose contribution is exemplary.

IMPORTANT NOTICE

There is no pay-to-play. Employees of a sponsoring organization **cannot** be nominated for an Award in the category with which their organization is supporting or aligned. However, we would welcome their nomination in other categories where appropriate.
